1. **Kapilvastu Hospital, Kapilvastu, Lumbini Province** has allocated funds from **Government of Nepal(GoN)** towards the cost of **Supply and Delivery of Medicine Item For Hospital Pharmacy** and intends to apply part of the funds to cover eligible payments under the Contract for **(Supply and Delivery of Medicine Item For Hospital Pharmacy Contract ID:01/NCB/Goods/KPH/2083/084**. Bidding is open to all eligible Bidders as defined in **ITB Clause 4 (Eligible Bidders)**.
2. The **Kapilvastu Hospital, Kapilvastu, Lumbini Province** invites **Hard copy** bids from eligible bidders for the procurement **Supply and Delivery of Medicine Item For Hospital Pharmacy** under National competitive bidding – Single Stage Two Envelope procedures.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the bidding documents at the office of **Kapilvastu Hospital, Kapilvastu** or may visit Hospital Website.
5. A complete *set* of Bidding Documents may be purchased from the office **Kapilvastu Hospital, Kapilvastu, Lumbini Province** and the office **Taulihawa kapilvastu** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NPR 5,000/ till 2083/06/26 during office hours in the account as specified below.

6. Pre-bid meeting shall be held .2083/06/16
7. Sealed or electronic bids must be submitted to the office **Kapilvastu Hospital, Kapilvastu, Lumbini Province** by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12 :00pm on 2083/06/27**. Bids received after this deadline will be rejected.



8. The bids will be opened in the presence of Bidders' representatives who choose to attend at (2083/06/27) 14:00pm at the office of **Kapilvastu Hospital, Kapilvastu, Lumbini Province**. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NPR 9,50,000/-, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a public holiday² applicable to purchaser, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.

² In case of electronic bid invitation, purchaser shall extend the deadline as required in the e-GP system.
